Important Notes re: Cost of Attendance (OCU program):

- 1) **Tuition is subject to change** with board approval. Modest increases are typical from year to year.
- 2) **Student Health Insurance** is required for On Campus Undergraduate students and optional for all others. The Prescott College student plan was \$2084 for Fall 2025 and \$3234 for Spring 2026 (included coverage for summer). Insurance rates for 2026-2027 will be determined in Summer 2026. On-campus undergraduate students may waive out of the campus plan if they are covered via another plan. Upon written request to finaid@prescott.edu, student insurance may be added on to Cost of Attendance if a student has not waived out.
- 3) **Student course fees** vary per course (See Schedule of Classes for details.)
Course fees will be added to cost of attendance after student registration upon student written request to finaid@prescott.edu. Course fees are typical for field courses and art courses. Certain courses that require extensive travel or extra accommodations costs are assigned an additional course fee -- see examples below. Food costs for field courses are usually shared with fellow students. Personal camping and backpacking equipment is required for most field courses. Certain adventure education courses require special personal equipment (e.g., cross-country ski boots and skis or a mountain bike.)
Example course fees:
Kino Bay Block course: \$600;
Kino Bay Session course (8 weeks): \$1050;
Kino Bay full term course: \$2100;
- 4) **Loan fees** may be adjusted to student's actual loan fees upon written request to finaid@prescott.edu.
- 5) A one time per program **computer allowance** up to \$2500 may be added on to a student's cost of attendance upon submission of an actual cost estimate via a student Cost of Attendance petition.
- 6) **Students may appeal** to add-on additional education-related expenses. Examples include childcare expenses, disability-related expenses, first-time professional license fees, exam fees, and additional transportation expenses for field courses. To do so, please:

- 7) **Payment Deadlines:**
Tuition must be paid in full or payment arrangements (payment plan or financial aid awards sufficient to cover tuition and fees) must be in place for each term by the following dates:
Fall 2026: July 3rd, 2026
Spring 2027: December 4th, 2026
Summer 2027: May 7th, 2027
Once you have confirmed your intention to enroll and registered, your bill will be posted in the student portal - My Academic Services. Students are responsible for checking this portal and paying their account balance by the posted deadlines. Students will not be permitted to participate in Orientation or matriculate from Prescott College until satisfactory payment arrangements are in place.

8) Tuition Payment Plans:

Should you wish to enroll in a tuition payment plan or have any additional questions about tuition payment, please contact a student accounts representative at 877-350-2100 ext. 4000 or online through My Academic Services > Finances > Make or Manage Online Payments.

9) Financial Aid:

If you expect to have financial aid cover part or all of your tuition and fees, you are encouraged to file the Free Application for Federal Student Aid (FAFSA) as soon as possible. Prescott College makes every attempt to ensure that all qualified students can attend and assists them in finding financial aid, given individual eligibility. 10) Program Specific Fees:

* Teacher Education Certification students are required to have a fingerprint clearance card before working with children. Fees vary by state. The national average is ~\$67, which is added into first term cost of attendance automatically.

** Adventure Education students are required to obtain Wilderness First Responder certification in order to graduate. This fee is paid to the course provider (multiple options) and varies upon location of course. Typical fees range from \$785 to \$915. This fee will be added to the student's Cost of Attendance in the term fee is incurred. Submit documentation of anticipated and/or actual fee via a Cost of Attendance petition to have fee added.
